



## J and J Riding Academy and Boarding Liability Agreement

I HAVE READ IT AND AGREE TO ITS TERMS. BY SIGNING THIS AGREEMENT, YOU (AND YOUR CHILD) ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR RECOVER DAMAGES IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE FOR ANY REASON. INCLUDING BUT NOT LIMITED TO THE NEGLIGENCE OF THE STABLE (J&J RIDING ACADEMY), ITS OWNER, PROPERTY OWNERS, EMPLOYEES AND AGENTS (aka Releases) ("The Release"). THIS RELEASE IS MADE PURSUANT TO NEVADA REVISED STATUTES 12-553

In consideration for allowing myself (or my minor child) to handle a HORSE and on behalf of myself, my child or personal representatives, heirs, next of kin, spouses and assigns I HERE BY: Acknowledge that Horse, Pony, Stallion, Mule, Donkey, may without warning or any apparent cause, buck, stumble, trip, roll, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on persons feet, push or shove a person, saddles and bridles may loosen or break, all of which may cause the rider to fall or be jolted, resulting in serious injury or death.

1. ACKNOWLEDGE THAT HORSES BACK RIDING IS INHERENTLY DANGEROUS ACTIVITY AND INVOLVED RISK THAT MAY CAUSE INJURY AND IN SOME CASES DEATH. Because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.
2. Acknowledge and willingly assume and accept full responsibility for all risk to personal safety and welfare including danger of injury or death inherent in handling of riding of the horse, and use of saddle, bridles, equipment and gear proved to me by Releases (J&J Riding Academy Owner, staff, working students and volunteers.)

3. Release, Discharge and promise not to sue the Releases for any loss, damages, injury (including death), or cost to me or my Childs persons or property arising out of riding or handling a horse, donkey, pony, mule, stallion, or use of saddle, bridles, equipment and gear provided by the Releases.
4. Release the releases from any claim that such releases were negligent in connection with me or my Childs riding a horse or pony, including but not limited to training or selecting horse, maintenance, care, fit or adjusting of saddle or bridles, instruction on riding skills or leading and supervising riders, which results in loss, damage, injury or death.
5. Indemnify, and save and hold harmless the Releases from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with either me or my child's handling or riding the horse, pony, and/ or use of saddle, bridles, equipment or gear provided therewith resulting from or contributed to by my own negligence.
6. Expressly agree that the foregoing release and assumption of risk, and indemnity agreement is governed by the laws of the STATE OF NEVADA and is intended to be broad and inclusive as is permitted by NEVADA LAW, and in the event any portion of this agreement is determined to be invalid or unenforceable for any reason, the balance of this agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
7. This agreement does not release or waive Releases liability or assume the risk of or indemnify form grossly negligent, willful, wanton or intentional acts or omissions of Releases.
8. Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Releases for any injury or damage in breach of this contract. I will pay all Attorneys fees and cost incurred by the Releases in defending such action.
9. IT IS RECOMMENDED THAT I, MY CHILD AND ALL RIDERS WEAR PROTECTIVE HELMET. IT IS MY UNDERSTANDING THAT A PROTECTIVE HELMET IS AVAILABLE AND HAS BEEN OFFERED FOR MY OWN, OR MY CHILDS SAFETY, AND IS REQUIRED IF UNDER THE AGE OF 18.
